The principals of RAS have significant experience working for municipalities in their disaster recovery cleanup efforts since Hurricane Andrew made landfall in Dade County, Florida in 1992.



EXPERIENCE & HISTORY

RAS is experienced in emergency management, logistics, recovery, debris loading and hauling, temporary debris site management, construction and demolition debris separation, sand screening, reclamation and building demolition.

In the aftermath of Hurricane Andrew, RAS President and Owner, Pedro Pelaez, served as one of the principal cleanup contractors for Dade County and the Cities of Miami, Miami Beach and Coral Gables. For a period of approximately 6 months, Mr. Pelaez's operation removed an estimated 2 million cubic yards of debris from the public right-of-ways.

RAS was hired by Miami-Dade and Broward Counties to participate in their disaster recovery cleanup efforts after Hurricanes Katrina and Wilma hit South Florida in 2005. During this effort, RAS removed a total of approximately 250,000 cubic yards from the public right-of-ways.

RAS loaded and hauled approximately 1 million cubic yards during the Hurricane Irma recovery effort. RAS ranked first in Miami-Dade County with respect to the overall debris removal and hauling effort.

RAS's experience, coupled with its long-standing relationships with companies in the disaster recovery industry, provides RAS with the means to offer a wide range of services and expertise to its customers.

RAS also has experience in dealing with the effects of sea-level rise and environmental threats to low-lying coastlines. Our knowledge speeds up recovery time by determining the type of debris which may be produced by a natural disaster in correlation with the severity of the disaster by identifying the appropriate level of response and specialized equipment needed for the job.
